INFORMATION CLAUSE IN THE CASE OF OBTAINING PERSONAL DATA OF A REPRESENTATIVE

1. The Administrator of your personal data is Koba Sp. z o.o. with its registered office in Białystok, ul. Mieszka I 4 lok 226 (hereinafter referred to as the "Administrator"). The Administrator can be contacted via email at iod@koba.pl, by post, or in person at ul. Piastowska 11, 15-207 Białystok.
2. The Administrator has appointed a Data Protection Supervisor, who can be contacted via email at iod@koba.pl, by phone at 85 333 33 33, by post, or in person at ul. Piastowska 11, 15-207 Białystok.
3. Your personal data will be processed for the purpose of concluding an agreement and carrying out cooperation with the entity on behalf of which you act.
4. The legal basis for processing your personal data is the legitimate interest of the Administrator, according to Article 6(1)(f) of the GDPR.
5. Employees of the Administrator, subcontractors, and entities providing services to the Administrator (e.g., IT services and technical support) who need access to the data to perform their duties will have access to your personal data.
6. Your personal data will be stored for the duration of the agreement and after its termination for the purpose of settling the terms of the agreement, including until the expiry of the limitation period for claims arising from such agreement (3 years from the termination of the agreement), and in terms of settlements with the tax office for the period of limitation of tax liabilities, i.e., 5 years from the end of the tax year in which the obligation to pay tax for the services provided arose.
7. You have the right to:
 - request access to your personal data, their rectification, erasure, or restriction of processing, as well as the right to data portability,
 - object to the processing of your personal data at any time, for reasons related to your particular situation,
 - lodge a complaint with the supervisory authority, i.e., the President of the Personal Data Protection Office.
8. Providing data is voluntary, but failure to do so will result in the inability to cooperate with the entity on behalf of which you act.
9. Your personal data will not be used for automated decision-making, including profiling.
